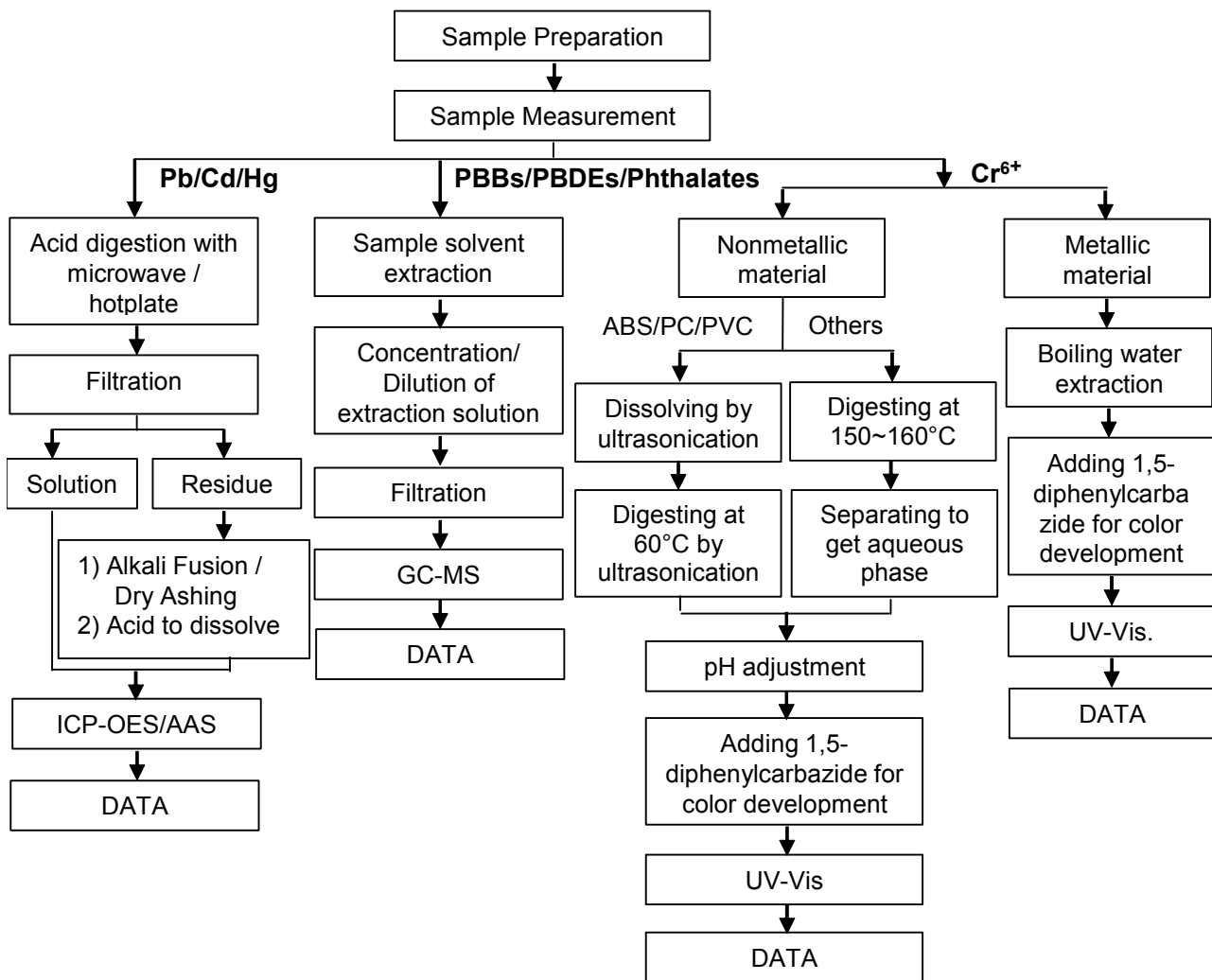

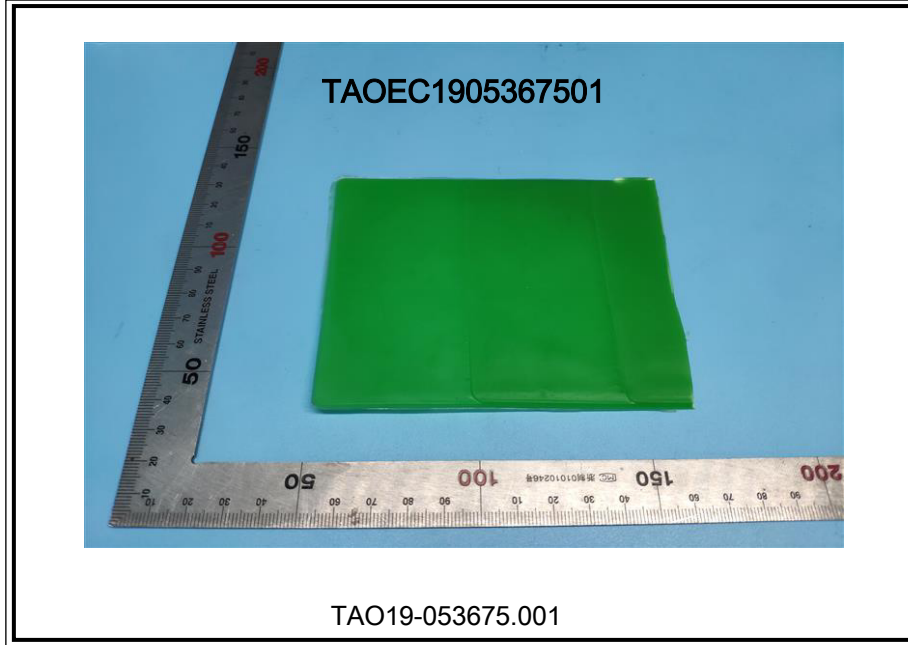
Pb/Cd/Hg/Cr⁶⁺/PBBs/PBDEs/Phthalates Testing Flow Chart
